**A.** Approval of minutes from the September 16, 2014, Planning Commission Meeting

to modify the comprehensive plan and zoning for their lands, collectively called "Grass Valley".

It was moved by Commissioner Hood, seconded by Commissioner Johnson to forward a recommendation of approval to City Council for the proposed 2014 Comprehensive Plan amendments as outlined in the October 16, 2014, Staff Report (File No. CPA14-04). The motion carried unanimously by roll call vote.

**B.** Amendments to Camas Municipal Code (CMC), Chapter 18.07, Use Authorization (Staff Report added on October 16, 2014)

Details: Amendments to the Camas Municipal Code Title 18 Zoning, Section 18.07.030 Table 1 - Commercial and industrial land uses. The amendments are to prohibit new residential uses in light industrial zones.

Department/Presenter: Sarah Fox, Senior Planner

The public hearing opened at 7:40 p.m.

Staff Report - Amendments to Light Industrial Land Uses (CMC14-03) 🤝

Ms. Fox gave a brief summary of the proposed code amendments.

Chair Hull opened and closed the public testimony portion of the hearing at 7:52 p.m., as there were no comments from the public.

Mr. Bourquin responded to the Commissioner's inquires about notifying the property owners who could be potentially impacted by the proposed amendments. After a lengthy discussion, the Commissioners recommended that when the proposed amendments go before City Council for a public hearing, the public notice that is published in the Post Record and posted around town will also be mailed to those potentially impacted property owners.

It was moved by Commissioner Johnson, seconded by Commissioner Short to forward a recommendation of approval to City Council for the proposed amendments to Camas Municipal Code §18.07.030 – Table 1 Commercial and Industrial Land Uses as outlined in the October 15, 2014, Staff Report (File No. CMC14-03) and that City staff notifies the property owners who may be potentially impacted by the amendments. The motion carried unanimously by roll call vote.

**C.** Workshop to Review Amendments to Camas Municipal Code (CMC), Title 16 Environment

Details: Amendments to the Camas Municipal Code, Title 16 Environment, Chapter 16.53 Wetlands. The proposed amendments will update the critical area regulations in compliance with a mandate from the Department of Ecology.

Department/Presenter: Robert Maul, Planning Manager

Mr. Maul stated that this item will be brought forward at a later date for a public hearing.

# V. MISCELLANEOUS UPDATES

Ms. Fox briefly updated the Commissioners on the progress made thus far on the 2016 Comprehensive Plan Update. She extended an invitation to the Commissioners and to the community to attend the 2016 Vision Summit that will be held on November 5<sup>th</sup> at Station No. 42. Ms. Fox also gave a brief update on the survey results.
