All Bid Proposals shall be accompanied by a Bid Proposal deposit in cash, certified check, cashier's check, or surety bond in an amount equal to five percent (5%) of the amount of such Bid Proposal. Should the successful Bidder fail to enter into such contract and furnish satisfactory contract bond within the time stated in the current updated version of the Washington State Department of Transportation (WSDOT) Standard Specifications for Road, Bridge, and Municipal Construction (standard specifications), the Bid Proposal deposit shall be forfeited to the City of Camas.

Work shall include but is not limited to non-structural partitions, floor, wall, and ceiling finishes, casework, built-up flooring, redistribution of HVAC in Children's Library Hallway, interior and exterior lighting, interior and exterior power distribution, exterior courtyard and associated area drain, updates to exterior monument signage, replacement of exterior vestibule and courtyard doors and associated hardware and card access readiness, replacement of historic windows, window heads, window sills, and window jambs, remediation of exterior stucco siding, mitigation of water damage at exterior historic wood doors and surrounds, flood barrier at top of exterior basement stairs, associated exterior waterproofing, ADA access control, ADA walkways, tree root mitigation at ROW sidewalks, skylight maintenance, landscaping, custom site furnishings, associated demolition and any related components shown within the plans and technical specifications to provide a complete and functional installation.
